SOLIDARITY

- This is a very difficult time to be a local authority in the United Kingdom
- The elimination of the deficit means a prolonged period of challenge for the public sector

PUBLIC FINANCES

- The United Kingdom finds itself in a position where it has "Sweden's public services with American taxes"
- The United Kingdom tax receipts are stuck at around 37% of GDP
- No deficit means spending cannot exceed receipts

CUTTING THE DEFICIT

• Not all the public sector has borne the effort to cut the deficit

- NHS,Overseas Aid, Welfare have been protected
- Local Government, police and capital investment has been cut.
- These areas have been cut from 20% 0f GDP in 2009/10 to 12.5% in 2019/20

THE FUTURE

- Public Expenditure in the UK is projected to fall by 40% between 2010 and 2020.
- Local Government will continue to fall unless taxes rise
- Politicians are not very good at raising taxes

NORTHERN IRELAND

- Local authorities have the benefit of a new start
- They have new powers for instance Community Planning
- The criticism of local authorities in England was that they had the powers but didn't seem to know they had
- In England a great reluctance for fear of legal challenge to use general powers of competence etc

TRANSFORMATION

- That is to say we all need to learn to do more with less
- Increasing local taxes not an option
- Productivity and driving out duplication etc a key priority
- Reduction in management overheads whilst improving front line services

RELATIONSHIPS

- The world of local government is all about sharing burdens and working together
- Shared Services
- Shared Management teams
- NB the chaos of devolution in England at present

RELATIONSHIPS-2

- Local authorities should challenge Central Government.
- Central Government are not always good at working together. They need help.

- In England we have failed at this.
