

Our Christmas Association meeting on the 14<sup>th</sup> December 2016 saw Ibrahim Hasan from Act Now Training deliver an excellent session on the forthcoming changes in Data Protection.



Ibrahim's expert and insightful delivery of the session was greatly received by all who attended with many now going away to forward plan for the imminent changes brought about by the New General Data Protection Regulation (GDPR).

Some of the key points from the session: GDPR replaces DPA 1998 from 25th May 2018; increased fines (up to €20 million); Subject Access Requests will be Free under new Regs; Data Subjects have the "right to be forgotten"; Data Protection statements should be clear/unambiguous/opt in.

RBI is replacing the Fraud and Error Reduction Incentive Scheme (FERIS) for 2017/18. The main differences between FERIS and RBI are shown below:

## **BENEFIT UPDATE**

- All available funding will be made as an up-front payment to LAs. There will be no baselines and thresholds which LAs need to meet to qualify for additional incentive payments.
- DWP are now asking LAs to use the additional funding to focus purely on combating incorrect earnings and use available funding to process as many Optional Real Time Information (RTI) referrals as possible each month. Other business as usual F&E activity should continue as normal, such as reviewing Earned Income cases which have not been reviewed in the last 12 months, reviewing Self Employed cases and using the new Real Time Information Service User Interface following the national roll out (WURTI).
- DWP will monitor the volume of referrals processed, cases reviewed and the outcomes through SHBE for each authority.
   There will be no requirement to submit an action plan to DWP to apply for funding. Once RBI is launched you will simply need to either opt-in or opt-out. As RBI focuses on earnings cases, funding will be apportioned across LAs based on the earnings caseload. The amount of funding available under this initiative will be communicated when RBI is launched and may be different to the previous FERIS funding for 2016/17.

This has not officially been launched but is expected before the end of March 2017.
