### Committal Action Abolished in Wales from 1st April 2019

Mark Drakeford, Cabinet Secretary for Finance announced on the 1st November 2018 that following the recent consultation, whereby WG received 188 from a wide range of stakeholders, proceedings to commit an individual to prison for council tax debt will be abolished from the 1st April 2019.

WG have given their commitment to work with local authorities to monitor implementation of the changes and if necessary consider the introduction of new measures.

### **Aggression and Behaviour that Challenges Workshop**

On the 22<sup>nd</sup> of November, 17 delegates from various local authorities and the private sector were in attendance at Conwy Council for the "Aggression and Behaviour that Challenges" training course delivered by Chris Burnard of Oakwood Training. Chris is a retired Operational Firearms Commander, Firearms Tactical Advisor and Weapons Training Instructor, who now works as a Personal Safety trainer for Oakwood.

#### The course focused on:

- Health and Safety Law and what it means for Personal Safety;
- How to dynamically risk assess everyday situations;
- Dealing with telephone aggression;
- Safety Tips and options for maintaining contact when working alone;
- How an understanding of verbal and non-verbal communication can keep us safer;
- Understanding your own conflict management style;
- Triggers to aggressive behaviour;
- Diffusion and De-Escalation techniques;
- The law around using force to keep yourself and others safe.


